

TERMS AND CONDITIONS FOR THE PURCHASE OF TICKETS TO PARTICIPATE IN HYROX EVENTS IN GREECE (HEREINAFTER THE "T&C")

1. GENERAL INFORMATION

1.1. VOLUME UP SPORTS AND ENTERTAINMENT EVENTS SINGLE MEMBER

P.C. with registered office at Davaki 17, Kallithea, in Athens, Greece and Vat Number 801514698 (hereinafter "**VOLUME UP/HYROX Greece**"), is the licensee of the HYROX brand in Greece, (hereinafter the "**Territory**") and organizes sporting events "**HYROX - THE WORLD SERIES OF FITNESS**" (hereinafter the "**Events**") in the Territory.

1.2. The HYROX season takes place through a series of Events in the Territory and other countries, ending with the HYROX World Championships of Fitness (event organized by Upsolut Sports GmbH, the company owning the HYROX brand) which may take place inside or outside the Territory. The Events of each season may be held in different cities of the Territory.

1.3. The different categories in which it is possible to participate in each Event are:

Individual category:

- HYROX PRO MEN
- HYROX PRO WOMEN
- HYROX MEN
- HYROX WOMEN

Double's categories:

- HYROX DOUBLES MEN'S
- HYROX DOUBLES WOMEN'S
- HYROX DOUBLES MIXED

Mixed Categories:

- HYROX MIXED RELAY
- HYROX MEN RELAY
- HYROX WOMEN RELAY

Each Participant may participate in all of the ten (10) possible categories.

1.4. Registration for the Events shall be made exclusively via the Internet and through the domains www.hyrox.gr; once the Participant(s)' data is entered, it will be redirected to a website operated by Ticket Socket, S2901 W. Coast Highway, Newport Beach, CA 92663/USA (a service company contracted by Upsolut Sports GmbH or by third designated parties), for the Participants to pay for the Event registration.

2. SCOPE

2.1. These T&Cs govern the legal relationship between HYROX GREECE and you as a participant ("**Participant**" or "**you**") in the Events taking place in the Territory. You are bound by these T&Cs if you accept them by checking the "I accept these terms and conditions" box for each Event in which you intend to participate, although these T&Cs will not become effective until you successfully register for the Event. No participant may participate in an Event held in the Territory without accepting these T&Cs.

2.2. HYROX GREECE may amend these T&Cs at any time, such amendment to be effective if you do not inform HYROX GREECE that you do not agree to the proposed amendments within seven (7) calendar days from the date of HYROX GREECE's communication.

3. CONDITIONS OF PARTICIPATION, EXCLUSION AND DISQUALIFICATION

3.1. Any person may participate in the Events if:

(i) on the date of celebration of the Event is at least 18 years old;

(ii) is in good health and physical condition;

(iii) has duly registered for the HYROX Event;

(iv) accepts these T&Cs and the RULES OF PARTICIPATION specified on the Registration Website; and

(v) is accredited in accordance with clause 7 or is in possession of an official race number.

(vi) your COVID-19 status at the time of the Event is either full COVID-19 vaccination with both or three doses received at least 14 days before the Event or your recovery certificate has not been expired.

3.2. If the participant is under 18 years of age at the time of registration, he/she will need to submit with the registration a written declaration of consent from his/her legal guardian. It must be signed and sent by e-mail along with a copy of the parents' identity document within two (2) calendar days from the date of registration, otherwise the registration will be cancelled.

3.3. It is the responsibility of each Participant to assess whether he/she is in sufficient physical condition and in good health to participate in the Event and should consult a doctor in case of doubt.

3.4. The requirements for a correct registration are: (i) the complete and truthful completion of the registration form on the Registration Website, (ii) the acceptance of these T&C and the RULES OF PARTICIPATION IN THE EVENT stipulated on the Registration Website, as well as (iii) the payment of the registration fee and all applicable fees, not being necessary to be a member of any sports center.

3.5. HYROX GREECE reserves its right to disqualify and/or exclude a Participant from an Event at any time if the Participant has provided false information about his/her personal data when registering. Also, HYROX GREECE has the right to exclude and/or disqualify Participants who do not comply with the instructions and requirements specified in these T&C or in the RULES OF PARTICIPATION specified on the Registration Website, as well as any other instructions communicated by HYROX GREECE before, during and/or after the Event. HYROX GREECE may communicate further instructions to the Participants through any of its duly appointed employees, and also through the members of the medical services supervising the Event, who, if there are sufficient indications in their judgment, may prohibit the Participants from continuing to participate, for their own protection.

3.6. HYROX GREECE reserves the right to disqualify and exclude Participants from the Event at any time and without refund of the entry fee and service fee, if there is sufficient suspicion that the Participant has taken substances not authorized by the competent authorities.

4. REGISTRATION AND CONCLUSION OF THE CONTRACT

4.1. The registration of Participants for an Event on the Registration Website does not constitute the conclusion of a contract between the Participant and HYROX GREECE, nor a binding offer by HYROX GREECE. The only contractual relationship between the Participant and HYROX GREECE shall be these T&Cs, which shall become effective upon successful completion of the registration.

4.2. The Participant must choose the category in which he/she wishes to participate at the moment he/she registers for the Event through the Registration Website. Once this step has been completed, the Registration Website will guide the Participant through the process to complete the registration.

4.3. The Participant does not have to create a user account to register for an Event. Each Participant may verify his contact details by creating a guest account. Each Participant is responsible for the accuracy of his personal data.

4.4. Upon completion of the above, should the Participant still be interested in completing the registration for the Event, after careful reading, he/she must accept these T&C and the RULES OF PARTICIPATION IN THE EVENT stipulated on the Registration Website by clicking on the corresponding checkboxes. If the participant is under 18 years of age at the time of registration, he/she will need to submit with the registration a written declaration of consent from his/her legal guardian. For it to be valid, it must be signed and sent to HYROX GREECE by email along with a copy of the parents' identity document within two (2) calendar days from the date the registration is made, otherwise the registration will be automatically cancelled.

4.5. To complete the registration process, the Participant must pay the corresponding registration fee, indicated on the Registration Website.

4.6. Once the payment has been made, if it has been made correctly, the Participant will receive a confirmation of receipt of the application together with a confirmation of payment, to the email indicated by the Participant on the Registration Website. In

case there is any error in the information included in the confirmation email, it is the obligation of the Participant to inform HYROX Greece immediately of such error so that it may proceed to modify it. To communicate such errors, the Participant must send an email to the following address: info@hyrox.gr After a reasonable period of time HYROX Greece will send a second email (hereinafter the "**Registration Confirmation Email**") indicating whether it accepts the Participant's request for the Event (Positive Answer) or denies it (Negative Answer). HYROX Greece reserves the right to not accept participation requests if it deems it necessary, without the need for any justification.

4.7. A Participant is deemed to have successfully registered, and therefore these T&Cs are deemed to take effect, at the moment the Participant receives a Positive Registration Confirmation Email from HYROX Greece. In the event that HYROX Greece does not accept a Participant's registration, the Participant will be refunded for the amount he paid.

4.8. Each Participant must register himself/herself for each Event. In the case of doubles categories, one of the Participants may register his or her partner by providing his or her data. However, in order to complete the registration of the couple, both Participants must accept these T&C and the RULES OF PARTICIPATION IN THE EVENT, by accepting both texts through the link that will be sent to their email address or onsite during their check in to participate. No Participant may participate in the Event without having previously accepted these T&C and the RULES OF PARTICIPATION IN THE EVENT.

5. PRICES, SERVICE FEE AND PAYMENT TERMS

5.1. All prices indicated on the Registration Website include the legal value added tax applicable in the Territory.

5.2. The applicable service fee shall be indicated on the Registration Website, specifically in the purchase order summary that appears before the Participant makes payment, in which the amount corresponding to the Event registration fee shall also appear.

5.3. Payment of the registration fee and service fee can only be made through the web platform established on the Registration Website. Payment will be handled by our registration partner. The Participant may settle the outstanding amount using the following payment methods: Credit Card, Google Pay, Apple Pay and Visa Checkout.

5.4. If payment is not made due to lack of credit or revocation of the account holder (even after the end of the registration), HYROX GREECE may terminate these T&Cs by simply informing the Participant at the email address provided in the registration and may charge the Participant for the costs of termination. The costs arising from a returned debit note include a processing fee of HYROX GREECE in the amount of EUR 10,00 plus the corresponding VAT, as well as the fee of the relevant bank, and shall be borne entirely by the Participant.

6. ADJUSTMENT OF THE CONTRACT - CHANGE AND RE-REGISTRATION

6.1. The Participant has the possibility, until the deadline of two (2) weeks before the date of the celebration of the Event ("**Deadline**"), to propose to change the category in which he/she participates - Singles/Doubles - or HYROX Women - HYROX PRO Women / HYROX MEN - HYROX PRO MEN or HYROX MIXED RELAYS.

6.2. Changes may be made only through the Registration Website, for which participants must send an email to info@hyrox.gr and follow the instructions provided. In addition, to complete any change, the Participant must pay the corresponding fees, in addition to other costs that may be applicable, which HYROX Greece will indicate prior to the confirmation of the change.

Individual registration:

- Change of division (HYROX WOMEN to HYROX PRO WOMEN or HYROX MEN to HYROX PRO MEN) - fee of 10,00 euros.

Doubles registration:

- Change of a competitor (change the name of one of the two competitors of the Doubles pair) - fee of 20,00 euros.

Mixed Relay Registration:

- Change of a competitor (change the name of one of the four competitors of the mixed relays) - fee of 30,00 euros.

6.3. To all processing fees and any other costs incurred shall be added the legally applicable value added tax.

7. ACCREDITATION/CHECK-IN/ACCESS TO VENUE

7.1. The Participant will receive the accreditations to enter the Event through an e-mail sent to the address indicated in the registration. He/She must show this accreditation in order to confirm his participation in HYROX on arrival at the Event, together with his National Identity Card, Driving License or Passport.

7.2. Each Participant is obliged to check that his data are correctly indicated on the badges, no claims will be accepted at the entrance of the venue where the Event is held.

7.3. On the Event Day you are required to check-in in person (no representation possible) in order to receive your race kit and access to the Event's Venue. You will be checked-in for the Event subject to presentation of the following:

- (i) the official confirmation of your participation either on a smartphone or printed out, and
- (ii) a valid photo identification (ID/ passport), and

(iii) your COVID-19 status certification.

7.4. Dependent on your physical appearance HYROX GREECE may request further information regarding your state of health and fitness. In case of apparent COVID-19 typical symptoms such as e.g., shortage of breath, cough, fever, or other indications of a persisting coronavirus infection, HYROX GREECE may refuse check-in and deny access without any further liability and reimbursement of entry fees.

7.5. You are obliged to check your race kit for completeness immediately upon receipt. Please note that the timing chip transponder that is part of your race kit must be returned to HYROX GREECE after finishing; please simply hand it to our staff located within the Finish Zone. In case of loss HYROX GREECE's damage will be € 55 for which you will be held accountable for.

8. CANCELLATION OF THE EVENT/NON-ATTENDANCE OF THE PARTICIPANT

8.1. HYROX GREECE has the right, in cases of force majeure or if a sufficient number of Participants have not registered, to make changes in the dates of the Event, in the venue or to cancel the Event completely. In case of cancellation of the Event, the registration fee will be refunded to the Participants, without refunding the service and bank fees.

8.2. In the event that the Participant does not attend the Event, for whatever reason, he/she shall forfeit any right to reimbursement from HYROX GREECE.

9. LIABILITY, LIMITATION AND EXCLUSION OF LIABILITY

9.1. Participation in the Event is at the Participant's own risk.

9.2. Participation in the Event requires that the Participants are healthy and in good physical condition.

9.3. By registering for the Event, each Participant expressly declares that he/she is aware of the specific dangers of the Event and that he/she has no health problems.

9.4. In the event of HYROX GREECE's slightly negligent breach of primary obligations, its liability is limited to the damage actually caused and foreseeable. HYROX GREECE shall not be liable in the event of slightly negligent breach of secondary obligations. In this context, primary obligations are those whose fulfillment is a prerequisite for the proper execution of these T&Cs.

9.5. HYROX GREECE assumes no liability for the loss of clothing, valuables and equipment of the Participants. In the event that the Participants hand over their objects to HYROX GREECE for safekeeping, HYROX GREECE shall only be liable in case of intent and gross negligence.

9.6. Insofar as the liability of HYROX GREECE is excluded or limited, this also applies to the personal liability of its employees, workers, staff, representatives and vicarious agents.

9.7. Please be informed, that HYROX GREECE can only limit yet not exclude the risk of getting infected with the Coronavirus notwithstanding all COVID-19 certification requirements and health and safety measures in place at the Event. By registering and checking-in for the Event you acknowledge and accept such COVID-19 related risk!

10. DATA COLLECTION AND PROCESSING

10.1. The Participant accepts that his/her personal data indicated in the registration form will be stored and used by HYROX GREECE and its partners and/or suppliers for the correct holding of the Event.

10.2. The personal data provided by each Participant during registration will be stored and processed by HYROX GREECE or by the service providers commissioned for the conduct and management of the Event, including medical assistance. The processing of personal data is carried out in accordance with the provisions of the General Data Protection Regulation. Data is stored in particular on the data necessary for the processing of the registration payment; all Event-related communication with you as a Participant takes place exclusively by e-mail.

10.3. Personal data shall only be used and transferred for Event-related purposes, furthermore such data shall only be stored for as long as necessary for the original purpose of its collection in connection with the Event. This may extend beyond the duration of the Event, e.g. for tax or legal inquiries.

10.4. The timing device must be returned to the person in charge by HYROX GREECE directly after the finish in the finish area. If the device is not returned HYROX GREECE will charge the Participant a fee of 55.00 euros.

10.5. The Participant agrees that the following data: his name, his start number, his results and his position in the Event, will be published in all digital (or printed) media related to the Event, as well as in all electronic media of HYROX GREECE.

10.6. If the Participant has registered for the HYROX GREECE "HYROX GREECE EVENT", as part of the registration process, he/she will be regularly informed about news, training and Event offers. The processing of personal data is carried out on the basis of the applicable legislation. Participants may unsubscribe from this newsletter at any time without incurring any costs other than those of modification according to the basic rates specified in this document. In each email sent, you will find the corresponding unsubscribe function.

10.7. The Participant has the right to receive free information about his stored data and, if necessary, the right to correction, blocking or deletion of this data. If you have any further questions about the collection, processing or use of your personal data, please contact HYROX GREECE at info@hyrox.gr.

11. PHOTOGRAPHY/FILMING AND IMAGE RIGHTS

11.1. HYROX GREECE informs that the Event will be recorded in its entirety, including the official competition, pre- and post-competition phases (athletes' area, technical briefing, start/warm-up area, competition area, entertainment area, awards ceremony), in the form of photographs and audio/video material. HYROX GREECE will store the recorded material and make use of it for information and marketing purposes through any media without time and space restrictions, as well as to allow the same unrestricted use and utilization by official HYROX partners/sponsors. The Participant explicitly accepts the use that HYROX GREECE may make of its images within the context of the celebration of the Event.

11.2. In any case HYROX GREECE will respect the rights of each Participant. Photographs and individual audiovisual material of the Participants in connection with the Event, e.g. in the context of the award ceremony, shall in any case be considered as classic photos of the Event, and HYROX GREECE shall be entitled to make use of such material.

11.3. HYROX GREECE guarantees that the material obtained shall be used exclusively in connection with the Events, even if it is passed on to authorized third parties.

11.4. HYROX GREECE is entitled to store, use, broadcast, perform, duplicate and/or publish all material obtained at the Event. This also includes the right to make changes, edits, interruptions, deletions or other modifications to the material and to use it without restriction. Furthermore, HYROX GREECE is entitled to transfer these rights to third parties freely.

11.5. The Participant is not entitled to approval of the content of what HYROX GREECE publishes, to its mention as a Participant or to receive financial compensation in case of mention or illustration or reproduction of any audiovisual material obtained at the Event.

12. COMPETITION RULES

12.1. THE RULES OF COMPETITION are available on the website: www.hyrox.gr. Participants accept these rules with the formalization of the registration, accepting them specifically by clicking on the corresponding box.
